Conversion of Scandic's convertible bonds in an aggregated nominal amount of SEK 383.4 million to shares

In 2021 Scandic Hotels Group AB (publ) ("Scandic") issued convertible bonds in an aggregated nominal amount of SEK 1,800 million. Convertible bonds in an aggregated nominal amount of SEK 383.4 million have been converted to shares. After the conversion, the aggregated nominal amount for the outstanding convertible bonds amounts to SEK 50 million.

Through the conversion, the total number of shares and votes in Scandic increases with 8,841,823 to in total 218,004,846. Through the conversion, the share capital increases with SEK 2,210,455.75 to in total SEK 54,501,211.50.
